taxpa Section 19 (Chapter 5) of The Model Goods and Service Tax Law provides for need registration of every taxpayer within 30 days from the date on which he becomes notliable for registration under the GST law. The said provision also stipulates that for enrol those persons registered under an earlier law, fresh registration need not be sought, rather the procedure prescribed be followed. the-

For the purpose of the existing registered persons, on October 24th, the Good§9stand Services Tax Network (GSTN) Chief Executive said that effective November Syste 8th enrolments will be released to enable existing registered persons to be moved porta into the GSTN. The number of such persons is 80 lakhs. in

In this direction, viz. to facilitate "enrolment" of persons under the GSTN, the  $^{\rm N-}$ GSTN has issued a set of FAQs, containing 56 questions and answers. The FAQs<sup>he-</sup> explain that the "enrolment under GST means validating the data of existing tax gstpayers and filling up the remaining key fields." It has been clarified that the payers enrolment for GST will ensure smooth transition to GST regime and the data porta available with various tax authorities is incomplete and thus fresh enrolment has axpe been planned. Per the FAQs, initially persons registered for other than service tax<sup>need</sup> date. This enrolment process is common to all taxpayers and is also common to the date. i№htե both Central GST and State GST.

As India moves towards GST, the Government and other agencies are functioning feverishly to enable a smooth and effective transition into the new indirect taxes regime. As one of the initial steps, enrolments of existing registered persons are proposed to be commenced. ""This move will help them do business without any inhassle from April 1 next year, which is the likely GST implementation date. India the-Inc. too must gear-up and "enroll" for GST," says the Chief Executive. ast-
