World Trade Organization (WTO)

- [Malaysia initiates WTO dispute complaint against EU palm oil measures.](#)
- [The Arbitrator conducting the arbitration under Article 22.6 of the DSU for suspension of concessions in *India – Agricultural Products* \(DS430\) has notified that the decision will be issued in July 2021.](#)

United States and Europe

- [United States Department of Commerce \(USDOC\) issued findings preliminarily find that Navneet Education Ltd. and Super Impex did not make sales of subject merchandise at less than normal value during the period of review i.e., September 1, 2018 through August 31, 2019 in administrative review of the antidumping duty order on certain lined paper products from India.](#)
- [European Commission issued a notice that it is prepared to review AD/CVD measures in force where an interested party can demonstrate that the measures would have been significantly different if they had been based on information excluding the United Kingdom.](#)

- [Directorate General of Trade Remedies \(DGTR\) initiated Sunset Review of Anti-Dumping Duty imposed on imports of “Glazed/Unglazed Porcelain/ Vitrified tiles in polished or unpolished finish with less than 3% water absorption” originating in or exported from China.](#)
- [DGTR initiated Mid-Term Review to review the product scope of definitive Anti-Dumping duty imposed on ‘Nylon Filament Yarn’ originating in or exported from European Union and Vietnam.](#)
