World Trade Organization (WTO)

- Saudi Arabia initiates WTO dispute case against EU duties on mono-ethylene glycol
- Items proposed for consideration at the next meeting of Dispute Settlement Body
- WTO launches first online regional trade policy course for Latin American countries
- US Joins Services Domestic Regulation Talks

United States, Europe & Asia

- USITC Votes to Continue Investigations Concerning Urea Ammonium Nitrate Solutions from Russia and Trinidad and Tobago
- USITC Votes to Continue Investigations Concerning Acrylonitrile-Butadiene Rubber (NBR) from France, Korea, and Mexico
- USITC Institutes Section 337 Investigation of Certain Light-Based Physiological Measurement Devices and Components Thereof
- European Commission issues notice of initiation of an expiry review of the anti-dumping measures applicable to imports of certain cold-rolled flat steel products originating in the People's Republic of China and the Russian Federation
- USITC Makes Determinations in Five-Year (Sunset) Reviews Concerning Certain Carbon and Alloy Steel Standard, Line, and Pressure Pipe from China

India

- Customs commissioners can now decide security deposit in certain provisional assessments cases
- DGTR initiates sunset review investigation into antidumping duties imposed on imports of "Toluene Di-isocyanate" originating in or exported from China PR, Japan and Korea RP.
- DGTR issues final findings in Anti-Dumping Duty investigation concerning imports of "Melamine" from China PR.
- DGTR issues final findings in Anti-subsidy investigation concerning imports of "Viscose Rayon Filament Yarn above 60 deniers" originating in or exported from China PR
- DGTR issues final findings in Anti-Circumvention investigation concerning imports of Ceramic Tablewares and Kitchen wares, excluding knives and toilet items, originating in or exported from China PR
- DGTR terminates Anti-Dumping Original Investigation concerning imports of "Self-Adhesive Polyvinyl Chloride Film" originating in or exported from China PR
- UK aims to start negotiations for trade agreement with India this year
