- DGTR issues final findings in anti-dumping investigation on imports of PVC Flex Films originating in or exported from China PR
- DGTR issues final findings in anti-dumping investigation on imports of Wire Rod of Alloy or Non Alloy Steel originating in or exported from China PR
- DGTR issues final findings in anti-dumping investigation on imports of Axle for Trailers originating in or exported from China PR
- BIS extends existing quality control orders on Maleic Anhydride, Styrene Monomer and Acrylonitrile
