DRAFT QUALITY CONTROL ORDERS (QCOs) NOTIFIED AT THE WTO1

Before being notified into law, draft Quality Control Orders are notified to the World Trade Organization (WTO) Technical Barriers to Trade Committee (TBT) to allow all member countries to submit their feedback and comments within a 60-day period following the notification date.

In February 2024, India did not notify any draft QCOs to the WTO.

Note: Some QCOs provide additional time for compliance for the MSME sector i.e., 3 additional months for Small Enterprises and 6 additional months for Micro Enterprises.



ELP Comments

The producers of the relevant products will now have to obtain BIS certification for their products. To obtain such a license, both foreign producers and domestic manufacturers of these products would need to submit an application to the BIS seeking certification.

Further, the certification process will also require physical testing and inspection of the relevant products at the factory premises as well as parallel testing by a Bureau of Indian Standards (BIS)-authorized laboratory in India to verify the same. BIS certification is a time-consuming process and therefore it is recommended that interested producers make applications for certification at the earliest in cases wherein Quality Control Orders have been issued and are pending enforcement.

Entities currently involved with these specific products should proactively prepare and submit applications to the BIS for securing their license. This strategic move will grant them a first mover advantage over counterparts lacking BIS certification.
